- The quote should include the provision for the following:-3.
 - a) Removing the worn out acoustic enclosure and fixing original acoustic enclosure (available in this office) after necessary repair wherever required.
 - b) Replacing WORNOUT existing Diesel Tank with new Diesel Tank with similar specifications and measurements and also necessary provision may be done for connecting to the DG Set.
 - c) Replacing of existing Silencer and mufflers.
 - d) Alternator repair if required-optional (the amount quoted will be deducted if the said work is not required)
 - e) Replacing the existing Battery with new battery if required-optional (the amount quoted will be deducted if the existing battery finds good)
 - f) Painting Work (Complete paint work for the above DG-set, rails etc with appropriate anti rust coat wherever required).
 - g) Any other miscellaneous essential work need to be carried out apart from the above may be specified work wise.
 - h) All waste and scrap (above worn out acoustic enclosure, diesel tank.. etc) to be disposed of by the bidder and value for the said materials have to be incorporated in the quote in order to deduct necessary amount in the final bill.
 - i) Necessary diesel (50 ltrs) for trial run of the DG set.
 - On completion of the entire work, the trial runs of the DG-set are to be shown to the satisfaction of this office. Further, any fault arising during the first 6 months of handing over of the DG set to this office to be rectified and serviced by the bidder for free of cost. However cost of materials purchased if any will be paid on actual cost basis.
 - Interested parties possessing the requirements as under may submit their quote for the said repair work.
 - a) They should be registered with Sales Tax, Service Tax and should have a Pan No. and must have minimum 5 years experience in this business.
 - b) No advance will be paid and 100% of the amount will be paid after completing the work to the satisfaction of this office
