4. Interested parties should possess the following eligibility criteria:


(a) They should be registered with Sales Tax, Service Tax and should possess a PAN Number and have a minimum of 10 Years experience in similar nature of work;

(c) No advance shall be paid and One Hundred percent of the amount will be paid upon satisfactory completion of the work;
