ORDER No. 25 /2015

Sub: Promotion to the grade of Superintendent – Reg.

Consequent to the review DPC held on 23rd, 24th and 27th April, 2015 for implementation of the Hon'ble Andhra Pradesh High Court order dated 02.03.2005 and implementation of Hon'ble Mumbai High Court order dated 17.10.2003 in W.P No. 2378/2005, the seniority list in the grade of Inspector as on 01.01.2013 has been revised. Due to said revision, a review DPC meeting was held on 29.04.2015 to review the panel drawn by the DPC held on 26.09.2014 for promotion to the grade of Superintendent for the vacancy year 2014-15 due to Cadre Restructuring. Consequent to the above review, Shri. T Rajasekar (Emp Code: 3721) who was promoted is now moved to the subsequent panel for the vacancy year 2014-15 held on 29.04.2015 and is promoted as Superintendent in the said panel.

Consequent to the above review, Smt R Palaniammal, Inspector is moved to the panel of DPC dated 26.09.2014 for the year 2014-15 and promoted to the grade of Superintendent of Central Excise (Group-B Gezatted) on adhoc basis in the **Pay Band of PB2 : Rs.9300-Rs.34800 with corresponding Grade Pay of Rs.4800/-**, with immediate effect and on an in-situ basis.

02. The above officers will continue in their present place of posting till regular posting orders are issued and Smt. R Palaniammal is promoted on insitu basis and shall continue in her present place of posting till further orders.

03. Except for the change of names in respect of above two officers, the order No. 96/2014, 101/2014 and 118/2014 which were issued consequent to the DPC held on 26.09.2014 remain unchanged.

04. The officers promoted on Adhoc basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers so promoted any claim for continued officiation in the grade of Superintendent of Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.

05. The promotion now ordered is subject to outcome of the following:

- (i) Review of DPC in respect of Promotion Order No. 260/97 dated 29.08.1997 in the grade of Superintendent based on pending clarification / decision from DOPT / Hon'ble Supreme Court.
- (ii) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta.
- (iii) OA No. 551/2012 filed by the All India Central Excise & Customs SC/ST Employees' Welfare Association and another in the Hon'ble CAT Madras Bench.
- (iv) SLP pending before the Hon'ble Supreme Court against the Hon'ble A.P High Court order dated 07-03-2005 in Writ petition No. 2378/2005 filed by Shri S.S.L.Narayana and WP No. 45/2005 filed by Shri. Giridhar Prasad and others, as mentioned in the Board's letter F. No. A.32022/70/2003 AD-III A dated 26.09.2005. Therefore, the promotion of these officers to the grade of Supdt is also subject to the outcome of above SLP.
- (v) Other cases, if any, pending before any judicial fora

06. The promotion now issued is subject to the condition that the officers concerned join latest by 11.05.2015 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

07. The compliance report about the joining/non-joining of the officers should be sent to this office by the CCO (Service Tax, CBE & CCP Zones) and the concerned Commissionerates of the Chennai Zone by 15.05.2015.

08. This order is issued with the approval of the Competent Authority, Cadre Control, Tamil Nadu and Puducherry.
