02. All the promoted officers will continue in their present places of posting till regular posting orders are issued and they are required to continue to work and discharge the same duties and responsibilities as at present until further orders. Those officers who or on deputation should report to the undersigned at the earliest but not later than 15.04.2015.

03. The promoted officers may exercise their option for fixation of pay under FR 22(1)(a)(1) within one month from the date of receipt of this order. However, the officers who have been granted Financial upgradation under ACP/ MACP scheme prior to promotion to the grade of Administrative officer are not entitled for pay fixation.

04. The officers promoted but yet to attend the mandatory training should undergo the mandatory training for Administrative Officers as specified in the Recruitment Rules, 2013 within 2 years from their promotion, failing which they will not be considered for promotion to the post of Chief Accounts Officer.

05. The promotion now ordered is subject to outcome of SLP in CC No.5252-5284/2008 filed by the Department before the Hon'ble Supreme Court.

06. All the officers promoted should join on or before **10.04.2015**. If they fail to join by the said date, it will be treated that they have not accepted the promotion **abinitio** and all consequences arising as a result of non-acceptance of promotion shall follow.

07. Necessary compliance report regarding their joining should be sent by **22.04.2015**.
