LIMITED TENDER NOTICE

The Commissioner of Central Excise, Chennai I plans to furnish the office for 14 Superintendents and 10 Inspectors at 1st Floor (Room No.101) and 2nd Floor (Room No.201) of Main Building at Office of the Commissioner of Central Excise, Chennai I Commissionerate, No.26/1, Nungambakkam High Road, Nungambakkam, Chennai 600 034.

2. Interested parties possessing the requirements as under may submit their quote with complete floor plan / furniture lay out to accommodate the above officers.

3. Interested parties may please visit and download the tender details from the official website www.centralexcisechennai.gov.in and may inspect the premises at Office of the Commissioner of Central Excise, Chennai I Commissionerate, No.26/1, Nungambakkam High Road, Nungambakkam, Chennai 600 034 on any working day.

4. The quote should include provision of White Washing, wooden partition (enclosure), Storage Units, Electrical Fitting and fixtures, Electrical, Data, Telephone concealed Wiring, Tables and side table for Superintendents & Inspectors as applicable with respective chairs along with Visitors Chairs.

5. Interested parties should possess the following:

- a) They should be registered with Sales Tax, Service Tax and should have a PAN No. and must have minimum 5 years experience in this business.
- b) They should have carried out similar work for Central / State Government during previous 5 years and must have executed atleast two orders of more than 5 Lakhs.
- c) No advance will be paid and 100% of the amount will be paid after completing the work.

6. The envelope containing the quotation should be superscribed as "Quotation for supply of furnitures and fixtures (including electrical fixtures) at Nungambakkam" and should be addressed to the Additional Commissioner (P&V), 3rd Floor Central Excise Building, Nungambakkam, Chennai 600 34. The quotations along with the drawings should be in a sealed cover & it should reach the undersigned on or before 18.06.2015 by 15.00 Hrs.

7. The sealed quotation will be opened at 16.00 Hrs on the same day. The intending firms who would be allotted the tender must be in a position to complete the work within 30 days from the day of receipt of order.

8. The Commissioner of Central Excise, Chennai I has the power to accept / reject any tender without giving any reasons whatsoever and his decision would be final.
