विषय/Sub: Estt - Promotion to the cadre of Inspector of Central Excise - Regarding

Consequent to the Annual DPC for the year 2015-16 held on 25.03.2015, the following Senior Tax Assistants are hereby promoted on **ad-hoc** basis to the grade of Inspector of Central Excise (Group 'B' - Non-Gazetted) in the pay scale of PB-2 Rs.9300-34800 with corresponding Grade Pay of Rs.4600/- **with effect from 01.04.2015** on an **in-situ** basis. The promotion will be effective with effect from the date they join/assume charge as Inspector of Central Excise.

2. The officers promoted on adhoc basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers so promoted any claim for continued officiation in the grade of Inspector of Central Excise and the period of such service will not count for seniority or as qualifying service for further promotions. The officers who have already been granted financial up-gradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.

3. Their seniority in the grade of Inspector of Central Excise will be fixed after their regularization as per the orders in force.

4. The above promotion is subject to the outcome of the -

(i) Decision of the SLP (registered as CC No. 5272-5284/2008) filed by the Department before the Hon'ble Supreme Court of India, challenging the judgment of Hon'ble Madras High Court dated 13.04.2007 in the case of Shri A. Karunanidhi & Others, involving the issue of seniority.

(ii) Reference to the Board about the Qualifying Service required for promotion of Senior Tax Assistants to the grade of Inspector for the vacancies arising due to Cadre Review.

(iii) Any other cases pending before any forum and having a bearing on this promotion.

5. All the promoted officers will continue in their present places of posting till regular posting orders are issued and they are required to continue to work and discharge the same duties and responsibilities as at present until further orders. Those officers who are on deputation should report to the undersigned at the earliest but not later than **10.04.2015**.

6. All the officers promoted should join on or after **01.04.2015** but not later than **10.04.2015**. If they fail to join by the said date, it will be treated that they have not accepted the promotion ***abinitio*** and all consequences arising as a result of non-acceptance of promotion shall follow.

7. Necessary compliance report regarding the joining/non-joining of the officers should be sent to this office by **24.04.2015**.

8. This order is issued with the approval of the Competent Authority, Cadre Control, Tamil Nadu and Puducherry.
