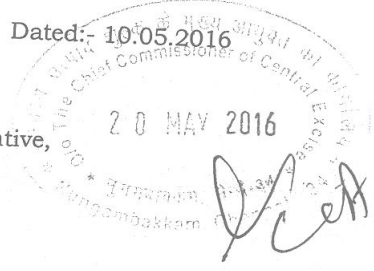

2. These posts will be filled up on deputation basis from amongst the officers of the similar rank working in the formations of Customs, Central Excise and Service Tax and officers holding analogous posts in the Directorate General/Directorates under CBEC in the same pay scale. **The age of the officer shall not exceed 56 years as on closing date of this circular.**

3. Such officers selected for a posting in the Directorate General of Systems, would normally be appointed for a period of 3 years but extendable up to 5 years.

4. It is requested that applications of the interested and eligible officers may be forwarded to this Directorate General with their particulars viz, name, address, educational qualification, date of birth, History of Posting, present post and the date from which it is held, scale of pay, experience along with synopsis of their ACR Gradings, for the last five years and also "No objection Certificate" from the concerned Commissionerate/ Director General/ Directorate within 90 days from the issue of the circular. It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their candidature and also will not be relieved till the expiry of the tenure of three years. It may also be certified that no vigilance case is pending or being contemplated against any such officer.
