Smt. S. Anandapadmavathi, Inspector (ad-hoc) is hereby reverted to the post of pre-restructured Tax Assistant (erstwhile STA now redesignated as Executive Assistant) as she doesn't fulfill the physical standards prescribed by the Recruitment rules, 2002 for the post of Inspector read with para 5 of Board's instructions dated 17.12.2008. This decision is an outcome of Board's clarification that "relaxation in the physical standards for promotion to the grade of Inspector cannot be considered" issued vide letter 19.07.2016 in reply to the grievance petition submitted by Smt. S. Anandapadmavathi.

2. In view of the foregoing, reversion of Smt. S. Anandapadmavathi from the grade of Inspector to the grade of pre-restructured Tax Assistant (erstwhile STA now Executive Assistant) has been approved by Cadre Control Authority.

3. Consequent to the reversion, her pay will be fixed in accordance with the existing instructions.

4. Her seniority will be fixed below Smt. Bhavani P. (SL.No. 125) of the revised seniority list in the grade of Senior Tax Assistant as on 20.01.2003 consequent to implementation of Hon'ble Supreme Court order dated 26.03.2015 and Hon'ble High Court of AP & Mumbai orders dated 07.03.2005 & 17.10.2003.

5. She is nominated to Central Excise Zone, Coimbatore on reversion. **Date of reversion will be deemed to be the date of issue of this order.**

6. Compliance report may be sent to this office immediately.

7. This order is issued with the approval of the Chief Commissioner, Central Excise Zone, Chennai.
