With reference to the above subject, it is stated that there exist five vacancies for the post of Authorised Officer in SEZ, Chennai and one vacancy for the post of Authorised officer in SEZ, Tirunelveli / Tuticorin Region. It has been proposed to fill up the said vacancies on transfer cum willingness basis. All Superintendents of Central Excise, who have not completed 56 years of age, are eligible for consideration. However, superintendents who had previously worked in SEZ, Chennai as Authorised officer are not eligible for posting again in SEZ, Chennai and they should not apply.

2. It is kindly requested that the same may be circulated among all the Superintendents working under your charge. The willingness of Superintendents to work in SEZ, Chennai, Tuticorin/Tirunelveli received if any, along with their vigilance clearance and APAR grading for the last 5 years, may be sent to this office on or before 15.05.2017 positively.
