The requests for corrections/additions/deletions received in the prescribed format from Inspectors have been carried out wherever necessary and has been finalised.

2. As already informed in the draft seniority list the Inter-se seniority according to N R Parmar judgment has been implemented from the revised panel drawn by the review DPC held on 15.05.2017 for the vacancy year 2011-12 (supp) for promotees who have been interspaced with the 2011 Direct Recruits. (Seniority No. 491 onwards).

3. The seniority of Inter Commissionerate transferees has been re-fixed in accordance to Para (ii) of Board's letter in F. No: A.22015/23/2011-Ad.III.A dated 27<sup>th</sup> October, 2011, which specifies that the Inter Commissionerate transferees will be placed below all officers appointed regularly to that post/grade on the date of his/her appointment on transfer basis in terms of Para 3.5 of DoPT's O.M dated 03.07.1986, read with Para 2.4.2 of DoPT's O.M No. 22011/7/86-Estt.(D) dated 03.07.1986 and DoPT's O.M F.No. 20011/1/2012-Estt.(D) dated 04.03.2014 on instructions relating to the N.R. Parmar Judgment.

4. The final Seniority list as on 01.04.2017 (copy enclosed) in the grade of Inspector of GST & Central Excise may be brought to the notice of all Inspectors working under your jurisdiction.

5. The final seniority list consists of two annexures A & B. "Annexure-A" contains the names of the Inspectors presently working and "Annexure-B" contains names of officers enlisted in the previous seniority list issued as on 01.01.2013 but since vacated the post on various events indicated (e.g. promotion, retirement, resignation, ICT etc.) against each.

6. Further, it is informed that the seniority list now issued is subject to outcome of pending cases, if any, in various judicial forums.
