

**Sub:- Preparation of panel for appointment of Intelligence Officer on deputation basis in the Directorate General of GST Intelligence (DGGI), Bhubaneswar Zonal Unit-reg.**

The Directorate General of GST Intelligence, Bhubaneswar Zonal Unit is in the process of drawing a panel of willing and suitable candidates for filling up the existing vacancies at Zonal Unit, Bhubaneswar and its Regional Unit at Rourkela in the grade of Intelligence Officer (IO) on deputation basis. As of now there are Three (3) and One (1) vacancy (ies) at Zonal Unit, Bhubaneswar and its Regional Units Rourkela respectively. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspectors in Customs and CGST/Central Excise (Govt. of India).

2. The selected officer, while working in the Directorate General in the grade of IO on a deputation basis, will be entitled for Deputation Allowance, as admissible. Normally, the deputation is for a period of five years which is extendable by another two years, subject to the willingness of the officer, his/her performance, and the concurrence of his / her parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised, would be final and in the event of selection, he will not be allowed to withdraw the same. Officers having minimum 3 years of experience in the grade may exercise their willingness through proper channel. Experience in Preventive / Anti-evasion are preferable.

The officers shall indicate their preferences amongst these two locations viz. Zonal Unit, Bhubaneswar or Regional Unit at Rourkela or both categorically.

3. It is requested that the circular may please be brought to the notice of all the formations under your jurisdictions and the applications of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information may be sent for evaluation by this Directorate viz.:-

- (a) Complete bio-data and willingness of the officer along with history of posting;
- (b) ACR/APAR grading for the last five (5) years duly verified and attested by the Additional /Joint Commissioner;
- (c) Vigilance Clearance Certificate;
- (d) "No Objection Certificate" from the Cadre Controlling Authority to relieve the officer in the event of his / her selection.

4. The above information/ details may please be arranged to be furnished to the Directorate at earliest, preferably by **04 May 2018**.

5. This circular is issued with the approval of the Pr. Additional Director General, DGGI, Bhubaneswar Zonal Unit, Bhubaneswar.
