5. After having completed Document Verification, the candidates will be subjected to Medical Examination and thereafter they will undergo Physical Endurance Test which will include walking and cycling. Candidates have to make their own arrangement for cycle.
6. Also, if the candidate has been issued with any Show Cause Notice (SCN), the reply of SCN along with proof of having sent the reply to the SSC should be brought at the time of verification without fail.
7. The candidates are also required to come prepared to stay for **-03- working days** for completion of the required formalities. It may be noted that the candidates have to make their own arrangements for boarding and lodging during the stay. No travelling or other expenses will be paid by the Department for attending the Certificate verification and physical endurance test.
8. If any candidate fails to report in this Office within the stipulated date, his candidature will be cancelled without further notice.
9. You are further informed that no further extension of time will be granted.
