**ORDER NO: 54 / 2018**

Sub: Promotion on notional basis to the grade of Inspector (SG)—  
 Opening of Sealed cover- in respect of Shri. D.Paramasivam ,  
 Superintendent (adhoc)-Reg.

Shri.D.Paramasivam was appointed as Inspector (OG) in the pay scale of Rs. 425-700 under direct recruitment quota. He was confirmed in the cadre of Inspector (OG) in March 1968. As per the DPC records Shri. D. Paramasivam was considered for promotion to the grade of Inspector (SG) in the DPC's held during the years 1973 to 1985. However he was not empanelled for promotion on account of a CBI case initiated against him, and the findings of the DPC were kept in a sealed cover.

2. The criminal case was registered by the CBI against Shri. D. Paramasivam, Inspector during 1976 . He was convicted in the case vide judgement dated 10.02.1996. Consequent to the conviction, Shri. D. Paramasivam , Supdt (Adhoc) (Expired on 19.11.2011) was dismissed from Service vide order dated 19.01.2004, issued in file C.No.II/10A/1/2003-Vig. Dated 19.01.2004 issued by Salem Commissionerate. The Appeal filed by him against the said order was rejected vide Order-in-Appeal dated 16.06.2005 issued by Salem Commissionerate. In the criminal Appeal filed by him against his conviction, the Hon'ble Madras High Court vide order dated 03.04.2007 acquitted him from all charges leveled against him . Further, Board vide F.No.C-16012/2/2008-Ad.V/5513 dated 08.11.2009 had set aside the Order-in-Appeal issued by Salem Commissionerate and granted all consequential benefits to him.

3. Consequent to implementation of Board's letter stated above, , the sealed cover Kept in the DPC held in December 1973 was opened and the findings of the DPC is reproduced hereunder:

“ Shri. D. Paramasivam , Inspector (OG) , was considered by the Departmental promotion committee held in December, 1973 and he was **found fit** for promotion subject to the outcome of the enquiry”

4. Accordingly in lieu of Para 2 above, Shri. D. Paramasivam is promoted on notional basis to the grade of Inspector (SG) w.e.f 05.03.1974 on par with Shri. N. Ramachandran (SC), immediate senior officer to Shri. D. Paramasivam (SC) . The fixation of pay is to be done in terms of instructions contained in FR22(1)(a) (i) .

5. This is issued with the approval of the competent authority, Cadre Control Zone, TamilNadu and Puducherry.
