Please refer to your online RTI application bearing Registration No. CEXCH/R/E/20/00070 dated 26.11.2020 filed under the RTI Act, 2005.

The reply to your RTI application is furnished here under:

**Reply to Point No. 1 :** The information sought for is not available as it does not fall under the definition of information under section 2 (f) RTI Act, 2005:

“ ‘information’ means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;”

However, as per the Recruitment Rules for the post of Tax Assistant notified vide G.S.R 12(E) dated 10.01.2014 as amended vide G.S.R 710(E) dated 15.09.2015, the eligibility criteria to be fulfilled for consideration for promotion to the grade of Tax Assistant are:

- (i) completion of 8 years of qualifying service in the grade of LDC failing which 8 years of combined service in the grade of LDC & Havaladar as on the crucial date from Lower Division Clerk to Tax Assistant.

- (ii) possessing educational qualification of 12<sup>th</sup> standard or equivalent from a recognized Board or University and
- (iii) Date Entry Speed of 8000 key depressions per hour for data entry work and passed the Departmental Examination with typing speed of 35 words per minute in English or 30 words per minute in Hindi on computer.

**Reply to Point No. 2 & 3 :** The requisite information is tabulated as under:-


**Reply to Point No. 4 :** For the vacancy years 2014-15, 2016-17 and 2019-20, no DPC was convened as there were no eligible candidates for promotion to the grade of Tax Assistant.

**Reply to Point No. 5 :** No LDC retired (eligible for promotion to the grade of TA) on superannuation as LDC, due to non-conduction of DPC in the grade of TA in the above said years.
